An acceptable alternative is to retag photos with the child's or adult's first name only to the ADP office location.
- World Vision will make every effort to monitor and/or moderate content posted on its social media and digital platforms and reserves the sole right to add, remove/delete or edit any comments it deems are inappropriate. Comments including but not limited to the following may be deleted or edited by the moderators:
  - o Comments that are in violation with WV's Safeguarding Protocol
  - Comments that expose children or adults in exploitive ways or which minimize their dignity
  - o Abusive or hurtful comments
  - o Off topic or redundant comments
  - o Comments that use foul language or "hate speech"
  - o Personal attacks or defamatory statements
  - Comments that violate the privacy, confidentiality and/or consent of sponsors, donors, or sponsored children and their families
  - Comments that contain a child's or adult's last name/surname, ID number, and/or child's personal location/address
