On 11 March 2020, the World Health Organization declared COVID-19 a pandemic. Within hours, World Vision launched its largest global emergency response ever in its 70 year history.

Working closely together with governments, partners, supporters, and communities at all levels, from grassroots to global, World Vision has worked to limit the spread of the disease and reduce its impact on the world's most vulnerable children and families.

Since the beginning of the pandemic, more than 1.5 million people have died globally, and over 68 million people have been infected. The pandemic's economic toll has left families, already living on the edge, out of work, has forced vulnerable children out of school due to lockdowns, and threatened millions more with hunger and starvation.

However, there is reason to hope. In recent days, news outlets worldwide have been reporting updates on promising vaccines. World Vision has deep experience and technical expertise – not to mention an impressive global footprint – which we can leverage to help end this pandemic. We recently released a vaccine capacity statement about World Vision's role in vaccine deployment. Our Partnership is well positioned to make a difference for children by helping to end this pandemic and by sheltering children and their families from the aftershocks of COVID-19.



Devastating aftershocks of the crisis are putting at least 85 million more children at risk of violence. Millions of parents and caregivers have lost incomes and jobs due to COVID-19, forcing 8 million children into child labour in Asia alone. As many as 1 million girls may drop out of school across sub-Saharan Africa due to teenage pregnancy and school closures. We urgently need to address both the direct health impacts of the virus and the secondary shocks brought about by viral containment measures

The impact from COVID-19 is threatening to reverse decades of progress in the fight against poverty and income inequalities. World Vision has warned that over 19 million people, including 10 million children, are at risk of famine in 12 of the world's most fragile countries due to a deadly mix of conflict, the economic impacts of COVID-19, and climate-related natural disasters.

Situation overview

Increasing vulnerabilities and worsening • humanitarian needs due to lockdowns have devastated livelihoods in sub-Saharan Africa.

School closures have negatively affected children's learning and led to higher teenage pregnancy rates. According to a recent World Vision study, as many as 1 million girls may drop out of school across sub-Saharan Africa.

Reduced funding commitments and COVID-19 lockdowns have increased vulnerabilities amongst forced migration populations (i.e. internally displaced persons and refugees) and migrant workers across east, west, and southern regions.

Reports indicate that gender-based violence and mental health challenges are also increasing due to lockdowns and lost livelihoods.

Countries across sub-Saharan Africa are facing a triple threat of issues from health, climate change, and loss of livelihoods with the COVID-19 pandemic; desert locust infestations in East Africa devestating vegetation; and flooding in parts of West and East Africa resulting in loss of life, displacement, infrastructure damage, inaccessibility to basic services, and crop disruptions.

Response highlights

- Trained 150 faith leaders and women in Angola on World Vision's 'empowered worldview' approach who reported that these skills and knowledge helped them to venture into sustainable economic activities to support themselves and their families.
- Facilitated a discussion at the 4th Alternative Mining Indaba Forum in the Democratic Republic of Congo between the government, international non-governmental organisations, and civil society organisations on the impact of COVID-19 on efforts to end the worst forms of child labour.
- Conducted verification processes, in partnership with communities, of food distribution beneficiaries in Eswatini, identifying the most vulnerable community members who qualify for support.
- Met with 35 'Savings 4 Transformation' groups in Lesotho to provide technical support and disseminate information on how groups should operate during COVID-19.
- In Mozambique, Citizens Voice Action committees compiled COVID-19 related concerns and suggestions, which will be shared with the government and other stakeholders.

Situation overview

Several countries in Asia Pacific are experiencing new surge of COVID-19 cases and have tightened restriction measures. On 11 November, the government of Mongolia announced a five-day nationwide lockdown to curb the spread of the virus. 1

At the same time, countries are faced with challenges of natural disasters, including floods, typhoon/cyclone, and La Niña. These recurring natural disasters, in addition to the ongoing pandemic and economic downturn put children at greater risk of food insecurity and make them more vulnerable to healthrelated issues.

World Vision is currently responding to floods and typhoons in Cambodia, Laos, and Vietnam. In the Philippines, the ongoing Typhoon Goni and Vamco Response has reached over 6,400 families with shelter, hygiene, and kitchen kits and non-food items. 1 While hurrying to support families with in-kind items, protection services, and cash assistance to reduce suffering and meet basic needs, World Vision also takes serious precautions to protect its staff and communities against the coronavirus.

Response highlights

- Due to a surge of cases in Ulaanbaatar, Mongolia, the government imposed a full lockdown, restricting movements across the country. World Vision will use its existing resources to conduct small-scale responses to support food and/or cash needs.
- Sri Lanka is also experiencing another wave of COVID-19. World Vision is updating its response plans and utilising existing resources to respond to the needs of the communities.
- The presence of multi-hazard risks in a global pandemic situation demands COVID-19 preparedness plans to rely heavily on realtime ground data and risk analysis combined with social registries of poor households at risk of hazard exposure to help with geographic prioritisation.

Situation overview

The number of COVID-19 cases in the Americas increased 30% during November, with more than 6 million new cases across the continent and North America presenting record daily numbers. The United States experienced a surge of cases after the massive mobilisation of travelers during the Thanksgiving holiday. Brazil, currently third in the global ranking of COVID-19 cases, with more than 6.6 million, has surpassed 175,000 deaths and announced that the country is in negotiation to buy the Pfizer vaccine. The World Health Organization also warned that the situation in Mexico was also 'very worrying', stating that the country is in 'bad shape'. Mexico accounts for more than 1.1 million cases and is fourth globally in number of deaths, with more than 110,000 losses. Since November, the country's weekly number of deaths has doubled from 2,000 to 4.000.

Besides the inequalities that challenge vulnerable people's access to timely medical services, the Economic Commission for Latin America and Caribbean and the Pan American Health Organization recently noted that the Latin America and the Caribbean lack an effective supply chain to ensure the availability of medical equipment and implements during this pandemic.⁴

Response highlights

- The Latin America and Caribbean region has reached 9.1 million people (45% of whom are children) with its COVID-19 response with the support of more than 38.000 faith leaders.
- World Vision issued standards for child protection and operation of child-friendly spaces in Latin America and the Caribbean amidst COVID-19. Teams throughout Central America are currently using these guidelines, which puts psychosocial support and emotional well-being of children at the centre.
- Field offices in Central America are expanding their engagement with housing-related agencies to ensure, not only reconstruction of homes, but also children's safety in communities.
- World Vision Honduras is reaching 1,000 children per week in shelters.
- The region has recently finalised a study that will be published in mid-December analysing the opinion of 27,000 children about their mental health.

Situation overview

In many places, events are posing challenges to attempts to tackle COVID-19. Since mid-October, Iragi authorities have closed 11 camps, forcing at least 27,191 residents to return to their places of origin, increasing the likelihood of the virus spreading. In Lebanon, the ongoing economic crisis and political turbulence is deepening the impact of the livelihoods and education crisis on children. Armenia is also facing increasing challenges as the end of the conflict with Azerbaijan is stimulating large population movements and the peace settlement has sparked a wave of political demonstrations that make handling COVID-19 even more difficult. Northwest Syria is recording high numbers of COVID-19 cases in a context where hospitals are illequipped to treat the volume of patients. In Romania, Georgia, Bosnia and Herzegovina, and Lebanon families are faced with a serious disruption in education as authorities struggle with a second wave of COVID-19 - 87% of children surveyed across the region fear falling behind at school.5

Response highlights

- The region launched Act Now for Children, a report on the hopes, fears, and recommendations of children about the pandemic, in November to mark the anniversary of the United Nations Convention on the Rights of the Child. We found that, for children, COVID-19 is a livelihoods crisis, with 60% of surveyed children worried about falling into poverty. Over 25% reported completely losing access to education, 50% experienced emotional violence, and 84% had feelings of isolation. Gender inequality also increased with girls taking on more household chores than boys. Building on this, the region has been challenged to listen more to children when designing our 2021 programmes, using Act Now's examples of evidence in action.
- At the field level, Afghanistan worked with local faith leaders and the Ministry of Religious Affairs and Haj to develop a 'Gender in Islam' training, which includes COVID-19 prevention and is applicable in other Muslim contexts. They also trained 52 faith and community leaders on child protection and reducing stigma of COVID-19.

Global, regional and national policy changes achieved through advocacy and external engagement to improve the international responses to COVID-19



- In commemoration of the **United Nations Convention on the Rights of the Child anniversary**, World Vision held 10 virtual events, in partnership with UNICEF, Global Partnership to End Violence Against Children, Arigatou, and other organisations, to launch <u>regional ACT NOW reports</u> and bring attention to the impact of COVID-19 in specific contexts.
- World Vision co-hosted the official side event for the **Afghanistan Donor Pledging Conference**, also releasing two reports: <u>Breaking point: COVID-19 and the child protection crisis in Afghanistan</u> and <u>A brighter future for children: Realising the nexus in Afghanistan</u>.

- World Vision's Syria Response successfully advocated with UNICEF, UNHCR, and the Syrian Inter-Agency Regional Forum to ensure that child protection vulnerabilities are featured separately in the Regional Refugee & Resilience Plan that informs national humanitarian response plans.
- World Vision Brazil worked with the government to develop and operationalise a local law to create child protection mechanisms as schools start reopening.
- World Vision Mexico prepared observations for 2021 public budget allocations that will have an impact on 3.8 million children and young people affected by the pandemic, especially those who are excluded from education or victims of child labour, violence, or migration.
- World Vision South Africa trained faith leaders on psychosocial support, who then assisted 941 children on how to deal with their emotions during COVID-19.

Humanitarian Accountability

A key focus for World Vision's COVID-19 response is to provide information, consult people on their needs and how they want to participate in their own self-recovery, and take action based on the feedback and complaints we hear from people so that we remain accountable to the children and communities that we serve. Here are the top trends of what communities* are telling us this reporting period:

Field offices reported that communities gave feedback requesting more support to enact the COVID-19 preventive behaviour messaging, that they needed more PPE, more WASH facilities, or were not able to follow social distancing advice due to work or family commitments.

We listen to communities and respond

Communities and partners recommended transmitting COVID-19 prevention messages in local languages. Based on this suggestion, World Vision Ecuador made sure that radio messages were transmitted in both Spanish and Kichwa.

Communities in Haiti remain sceptical about the existence of COVID-19: "Communities no longer believe in the existence of coronavirus, they believe that it was God who spared them from such a plague," said a community leader in Plateau Central. However, some schools are asking for masks for students and others are calling for handwashing facilities. In response, World Vision Haiti has continued and intensified the awareness sessions on the existence of COVID-19.

Local leaders and community members in Freetown provided feedback regarding COVID-19 response interventions. They appreciated World Vision Sierra Leone's interventions in the slum areas but requested that we truck water to three paediatric hospitals in the city to help with preventative behaviours. World Vision supported their request and is exploring how we can provide a more sustainable water supply for these facilities.
