

Analysis Design and Planning Toolkit for Child Protection in Humanitarian Action

A child protection assessment tool that seeks to inform contextually-relevant strategies and programmes to address child protection issues and strengthen the child protection system

- Suitable for use in contexts of emergency (not rapid onset) and protracted crises
- Prioritises listening to most vulnerable children and affected population
- Produces actionable recommendations for programme design, adaptation, advocacy

Lessons from the pilot - Uganda

Priority areas:

Placement of children in foster care and heightened vulnerability (at risk of violence, abuse, exploitation and neglect) Causes: extreme poverty, lack of livelihood, lack of services, high numbers of UASC, cycles of displacement



Lessons from the pilot - Lebanon


Priority areas:


Child labour, Violence (physical, verbal, emotional), early marriage. refugee/ host population tension

Causes

Poverty, lack of livelihood, customary practice







What we learned: 'Connecting the dots'








- How do we situate our work given the systemic issues? i.e. poverty, lack of livelihood etc.?
- Taking a more holistic and multisectoral view to addressing needs also for CP
- Understanding our role in the 'bigger picture' both internally within our organization and externally with others
- Do-no-harm while addressing issues and systemic gaps







- What does the national level analysis tell us for the work we do at the local level and vice versa?
- How do we strengthen accountability mechanisms?
- What are our short term, medium term and long-term goals?
- What happens with sustainability?







- Taking a more integrated, holistic approach
- Taking stock over time where are we, where do we want to be? Being able to tailor /adapt as context evolves.
- Who are the "unusual suspects" that we can influence and engage? (e.g. Shawish)
- Creating the evidence base for advocacy internally and externally

Considerations – moving forward







- Requires some level of in-country support (and perhaps some ongoing remote support) and preparations. Possibility of regional trainings?
- Some confusion in application for different contexts such as refugee and non-refugee
- Confusion over terminology, how do we avoid 'semantics'
- Roles and responsibilities (avoid being disjointed)
- Situated with other assessment initiatives
