“Board Chairperson’s Remarks



Transforming Lives Through Resilient Governance and Faithful Stewardship

It is my profound honour to present the Board Chairperson’s Report for the 2025 Financial Year. Throughout this period, the Board of World Vision Zambia provided ethical, transparent, and accountable leadership, ensuring the organisation remained anchored in the principles of integrity, fairness, and good corporate citizenship. In accordance with the National Corporate Governance Code 2026, we maintained a clear separation of roles between the Board Chairperson and the National Director to ensure independent oversight. All Board members served voluntarily, upholding a strict Conflict of Interest Policy and a culture of servant leadership.

The 2025 Financial Year was defined by significant humanitarian challenges, most notably the El Niño-induced drought and shifting geopolitical dynamics. In response, the Board focused its oversight on four strategic priority areas: risk and resilience to adapt programming to volatile climate conditions; financial stewardship to safeguard resources and monitor spending discipline; accountability to strengthen child and adult safeguarding mechanisms; and strategic direction to transition from emergency response to sustained local resilience.

Despite these environmental shocks, World Vision Zambia demonstrated exceptional reach and financial discipline. The organisation directly impacted the lives of 995,089 children and more than 1.8 million people across the WASH, Education, Health, and Livelihoods sectors. The Board ensured rigorous financial governance by reviewing quarterly audits and compliance updates to ensure that every dollar and every kwacha delivered measurable value to vulnerable communities.

Safeguarding remains a non-negotiable pillar of our governance. The Board maintained a zero-tolerance stance on harm, abuse, or misconduct, overseeing survivor-centred response processes and community feedback loops. Additionally, the organisation strengthened its Environmental, Social, and Governance commitments, integrating environmental stewardship into core operations.

Looking forward, the Board has established four imperatives to move from response to enduring resilience. These include scaling shock-responsive systems in agriculture and water security, sustaining momentum in domestic fundraising and private-sector partnerships, deepening collaboration with the Government of Zambia and faith leaders, and enhancing data quality and internal controls. The Board reaffirms its commitment to the highest standards of stewardship as we work with our donors and partners to bring lasting hope and sustainable well-being to every child in Zambia.

Board Chairperson's Report

For the Financial Year Ended 30 September 2025



1.0 Introduction

It is my honour to present the Board Chairperson's Report for the 2025 Financial Year. The Board provided ethical, transparent, and accountable leadership throughout the year, ensuring that World Vision Zambia remained aligned to the principles of integrity, fairness, responsibility, transparency, and good corporate citizenship.

2.0 Operating Environment

FY25 was characterised by significant humanitarian and developmental challenges, including geopolitical decisions that had substantial effects on the humanitarian sector, as well as severe climate related shocks such as the El Niño induced drought and its cascading impact on communities. In this context, the Board's role was to safeguard clarity of mission, uphold the integrity of organisational systems, and ensure continuity of impact across all programme areas. Accordingly, the Board focused its oversight on four priority areas:

2.1 Risk and Resilience

ensuring our programming and support functions could adapt to rapidly changing conditions.

2.2 Financial Stewardship

safeguarding resources, monitoring liquidity and spend discipline, and enabling rapid scale up where needs were greatest.

2.3 Accountability and Safeguarding

strengthening prevention, reporting, and response mechanisms so that every child we encounter is protected and every concern is acted upon.

2.4 Strategic Direction

guiding a transition from response to sustained resilience, local resource mobilisation, and partnership diversification.

3.0 Governance and Oversight




The Board continued to discharge its mandate effectively, having duly convened and held the required meetings, ensuring robust governance.

In line with World Vision's global governance model and our commitment to servant leadership, all Board members of World Vision Zambia serve on a voluntary basis and do not receive remuneration for their service. Only reimbursements for approved, reasonable expenses directly related to Board duties are provided.

The Board maintained strict adherence to its Conflict-of-Interest Policy, with all directors making the required annual and meeting-by-meeting disclosures.

Key actions undertaken included:

3.1 Strengthening Oversight Structures

-  Reinforcement of Board and Committee effectiveness through review of Terms of Reference and governance tools such as the Board Charter, Code of Ethics, and Committee Charters.
-  Continued separation of the roles of Board Chairperson and National Director, ensuring independence and objectivity in leadership oversight.
-  Review of the Organisations Strategy ensuring alignment with the organisations purpose and legitimate expectations of the stakeholders.

4.0 Organisational Performance

4.1 Impact and Reach

6.0 Ethical Culture, Integrity and ESG

The Board reinforced the ethical culture of the organisation, ensuring adherence to the Code of Ethics and safeguarding principles. Whistleblowing systems remained effective, confidential, and well-utilised. The organisation strengthened its ESG commitments, integrating environmental stewardship, social responsibility, and ethical governance into core operations.

3.2 Board & Committee Performance

-  Regular performance evaluations for the Board, the Board undertook its externally facilitated evaluation consistent with governance best practice requirements for annual assessment and continuous improvement.
-  Ongoing training and development to strengthen Board competencies in strategy, risk governance, compliance, and ESG oversight.

3.3 Compliance and Risk Governance

-  Regular monitoring of risk through quarterly reporting by management, with a heightened focus on humanitarian risks, safeguarding, financial stewardship, and regulatory compliance.

5.0 Financial Performance and Stewardship

World Vision Zambia demonstrated strong financial performance and disciplined stewardship of donor resources.

The Board reviewed quarterly financial reports, audit findings, and compliance updates, ensuring transparent and accountable financial governance in line with the Code's transparency and disclosure standards.

7.0 Stakeholder Engagement

The Board promoted strong collaboration with key partners:

- The Government of the Republic of Zambia, through its line ministries and local authorities
- United Nations agencies and international humanitarian clusters
- Donor offices and global support partners
- Disaster Management and Mitigation Unit (DMMU)
- VisionFund Zambia
- Community leaders, churches, and civil society

We remain grateful for the trust and partnership extended to World Vision Zambia during a year of significant national need.

8.0 Board Development and Succession

The Board undertook skills development and governance training for all directors. Succession planning reviews for the Board, senior leadership, and key management roles. Strengthening Board diversity and inclusion, ensuring balanced competencies to support effective oversight.

9.0 Child and Adult Safeguarding

Safeguarding remains a non negotiable pillar of our governance. The Board has maintained close oversight of prevention, reporting, and survivor-centred response processes, with particular attention to training, community feedback mechanisms, and complaint-resolution pathways embedded in humanitarian programming. We remain unwavering in our zero tolerance stance on harm, abuse, or misconduct, and we will continue strengthening controls and culture to keep every child safe.

11.0 Conclusion

As we conclude the 2025 reporting period, the Board reaffirms its commitment to upholding the highest standards of ethical leadership, accountability, transparency, and stewardship.

Finally, the Board confirms that World Vision Zambia complied with all applicable laws, regulatory requirements, and governance standards. The Board continues to apply and explain the principles of the National Corporate Governance Code, 2026 ensuring transparent disclosure in this Annual Report. During the year under review, the Board strengthened its oversight role by promoting accountability, transparency, and ethical leadership across all levels of the institution.

In line with the Code, the Board ensured clear separation of roles between management and the Board, enhanced risk management practices, and reinforced internal controls to safeguard stakeholder interests. The Board also prioritised sustainability, and long-term value creation, consistent with national governance expectations and international best practices.

Compliance remains integrated into the organisation's risk management framework, and management has demonstrated a strong commitment to continuously strengthening compliance practices.

World Vision Zambia remains committed to transforming the lives of the most vulnerable children. We will continue to uphold the highest standards of ethical governance, programmatic excellence, and partnership as we work with our communities, Government, donors, and faith partners to bring lasting hope and sustainable well being to every child we serve.

10.0 Strategic Outlook

integrating shock responsive systems across sectors, from water security and climate smart agriculture to nutrition and school feeding.

This is how we will move from a successful response to enduring resilience without losing sight of the child at the centre of our work.

10.3 Partnerships for Scale

deepening collaboration with Government, faith leaders, community structures, and multilaterals to reach more children, faster.

10.4 Assurance and Learning

continuing to strengthen internal controls, safeguarding, data quality, and evidence based decision making to ensure that every kwacha and every dollar delivers measurable value to children.



“National Director’s Foreword



Over the past year, Zambia has faced significant challenges, particularly the effects of climate change and the El Niño-induced drought, which have impacted food security, water availability, and the well-being of vulnerable communities.

Despite these challenges, World Vision Zambia has continued to deliver impactful, integrated programming at scale. In 2025, we reached over 1.8 million people, including 995,089 children, through our development and humanitarian interventions.

This includes measurable improvements in foundational learning outcomes, with Grade 3 reading comprehension increasing from 41% to 54% in supported schools. Across sectors, our work has strengthened community resilience, improved access to essential services, and supported households to better cope with climate and economic shocks.

Our approach integrates community engagement, systems strengthening, and strong partnerships with government, UN agencies, and the private sector to deliver sustainable and scalable impact.

As we look ahead, we remain committed to deepening our impact and expanding our reach. Building on these results, we will continue to scale integrated, locally led solutions that strengthen resilience, address the root causes of vulnerability, and deliver sustainable impact for Zambia’s most vulnerable children.

Education:

Strengthening school infrastructure and providing essential learning materials to ensure every child has access to quality education in a safe environment.



Child Protection:

Strengthening systems to enhance child protection in communities through local structures in schools, communities, district and national levels.



Health & Nutrition:

Empowering mothers and caregivers with health-seeking behaviours and nutritional support to combat stunting and improve maternal health.



WASH (Water, Sanitation, & Hygiene):

Expanding access to clean water and sanitation facilities to reduce waterborne diseases and improve community well-being.



Livelihoods:

Linking local entrepreneurs to viable, sustainable markets to boost household income and economic resilience.



Humanitarian & Emergency Response:

Providing rapid relief and long-term recovery support to communities affected by natural disasters and climate-related shocks.

Our **Vision for the Future**



We are driven by the fundamental belief that every child deserves the opportunity to grow in mind, body, and spirit. Our work is not merely about service delivery; it is about empowering children to experience life in its fullness, becoming all they were created to be, and reaching potential far beyond their initial circumstances.

Enhancing Child Well-being



Between 2021 and 2025, World Vision Zambia reached upwards of 2.1 million children, with 995,089 children impacted in 2025. The children have been reached through a multi-sectoral strategy encompassing child protection, health and nutrition, livelihood resilience, and foundational learning development. This integrated approach is anchored in four primary objectives: fostering positive spiritual and communal relationships, ensuring children are protected from violence and infectious disease, and achieving universal functional literacy.

By aligning community engagement with sponsorship plans, the organisation has created a sustainable framework for children to thrive within their local contexts.

Priority Areas



EDUCATION

In 2025, World Vision Zambia contributed to measurable improvements in foundational literacy, with reading comprehension among Grade 3 learners increasing from 41% to 54%.

A total of 129,045 children in Grades 1 to 4 benefited from a strengthened literacy system that improved both teaching quality and learning environments. 1,823 Teachers were trained and applied more effective, structured methods in the classroom, resulting in better learner engagement and improved reading outcomes across 633 schools.

Support extended beyond the classroom. Communities took an active role in children's learning through 1,061 reading camps, with 7,405 caregiver involvement. This created consistent reading support at school and at home, reinforcing skills and improving retention.

Early learning also improved, with young children gaining stronger pre-literacy foundations. At the same time, strengthened supervision systems ensured that teaching standards remained consistent and effective across target areas.

These combined efforts built a more supportive and accountable literacy ecosystem. Children are now reading with greater confidence and comprehension, setting a stronger foundation for progression through school and long-term learning success.

HEALTH & NUTRITION

In 2025, World Vision Zambia contributed to improved maternal and child health outcomes, with 94% of births attended by skilled personnel and increased uptake of essential nutrition practices among mothers and children.

World Vision Zambia strengthened child survival and maternal health outcomes by embedding improved practices within community systems. A total of 219,931 children and adolescents benefited, with measurable gains in nutrition, safe delivery, and infant care.

Child nutrition outcomes improved, with 698 children under five recovering from malnutrition and returning to healthy growth. Families adopted better feeding and care practices, reducing the risk of relapses and supporting sustained child development.

Maternal health outcomes also advanced. More women accessed timely health information and services, leading to safer pregnancies and deliveries. Among women reached, 11,798 delivered in health facilities, contributing to a high rate of skilled birth attendance at 94% across programme areas. This reflects stronger trust in health services and improved access to care.

Infant feeding practices showed steady progress. A total of 68% of children were exclusively breastfed for the first six months, improving immunity, growth, and survival chances in early life.

Community engagement played a key role. Increased involvement of men, women, and adolescents in health and nutrition practices led to better decision-making at the household level. Families acted earlier on health needs and adopted behaviours that reduce illness and support healthy child development.

These results point to stronger, community-driven health systems where children survive and thrive, and mothers access the care they need at the right time.

LIVELIHOODS

In 2025, World Vision Zambia strengthened household resilience by expanding access to financial services and improving participation in sustainable markets. A total of 26,514 people engaged in community savings groups, including 8,551 new members, increasing financial security and access to capital at the household level.

Market participation also improved, with 28,813 individuals joining Commercial Producer Groups. This enabled farmers and small businesses to secure more reliable buyers, increase productivity, and improve incomes through structured market systems.

Behaviour change played a central role in sustaining these gains. The Empowered Worldview approach reached 47,588 people, strengthening planning, resource management, and decision-making at the household and community level. As a result, 74% of households reported strong collective efficacy, reflecting increased confidence to work together, solve challenges, and invest in shared economic opportunities.

The community also demonstrated improved stewardship of natural resources, aligning livelihoods with environmental sustainability. Households adopted practices that protect productive assets and reduce vulnerability to climate shocks.

These outcomes show stronger, self-reliant communities with improved incomes, greater financial inclusion, and the capacity to sustain progress in the face of future risks.

WATER, SANITATION & HYGIENE

In 2025, World Vision Zambia improved access to safe water, sanitation, and hygiene, leading to healthier communities and reduced exposure to waterborne diseases.

A total of 216,943 people gained access to basic drinking water, while 28,878 children benefited from improved WASH services in schools. Households also made significant progress in sanitation, with 273,980 people accessing improved and dignified sanitation facilities. These gains reduced open defecation and lowered the risk of disease outbreaks.

Health and education outcomes strengthened as a result. Children spent more time in school, and communities reported fewer cases of preventable illnesses linked to unsafe water and poor sanitation.

Investment in durable water systems and sanitation facilities improved reliability and access in underserved areas. Schools and health facilities provided safer, more hygienic environments, supporting consistent service delivery and protecting the dignity of users.

Improved hygiene practices at household and community level reinforced these outcomes. Families adopted handwashing and sanitation behaviours that prevent disease and protect children's health. These results reflect stronger community resilience, with families better equipped to maintain health, reduce vulnerability, and sustain safe WASH practices over time.

HUMANITARIAN & EMERGENCY AFFAIRS

In response to severe climate shocks, World Vision Zambia delivered large-scale humanitarian assistance, reaching over 1 million people with life-saving support and early recovery interventions.

In 2025, Zambia faced one of its most severe humanitarian crises in over 16 years, driven primarily by the El Niño-induced drought, compounded by food insecurity, water shortages, disease outbreaks, and protection risks. In response, Humanitarian & Emergency Affairs (HEA) implemented a large-scale, multi-sectoral humanitarian operation, delivering life-saving assistance while laying foundations for recovery and resilience.

In 2025, World Vision Zambia interventions reached over 1.1 million people, significantly exceeding initial response targets, across 22 districts. The response combined emergency food assistance, cash-based transfers, WASH, nutrition, education, protection, and livelihoods support, demonstrating strong operational capacity and coordination.

Children are Safe, Protected and Nurtured

World Vision Zambia is dedicated to ensuring that effective legal systems that protect children from early child marriage, harmful traditional practices, and sexual and physical abuse are in place. Child Protection focused on strengthening legal and community-based protection systems.



Efforts reached **124,641 children** through spiritual nurture activities, while thousands of youth and community members engaged in 'Citizen Voice and Action' (CVA) initiatives to end violence against children. Strategic partnerships with UNICEF and Save the Children further amplified these efforts, providing platforms for child participation in governance and national advocacy.



Birth registration remained a priority for securing children's legal identities and access to services. In collaboration with the Department of National Registration, World Vision facilitated the issuance of birth certificates across Chongwe, Kafue, and Mungwi districts. These protection measures, combined with community-led advocacy, ensure that children are safeguarded from early marriage and exploitative practices while being nurtured within a supportive legal framework.

Advocacy

World Vision Zambia strengthened advocacy outcomes in 2025 by enabling communities and children to directly influence public policy and resource allocation.

Our Local Advocacy efforts influenced the allocation of ZMW 48 million in public resources through the Citizen Voice and Action (CVA) model, supporting community-prioritised infrastructure across 18 districts.

These resources supported improvements in more than 25 facilities across 18 districts, including schools, health services, WASH infrastructure, and local economic initiatives. As a result, communities gained better access to essential services and infrastructure that respond to their most urgent needs.

Citizen participation in governance increased. A total of 1,656 trained volunteers facilitated civic engagement processes that enabled communities to demand accountability and influence how public funds are used.


This led to more transparent decision making and stronger alignment between government spending and community priorities.


Children also influenced national policy discussions. Under the ENOUGH Campaign, 650 children engaged decision makers on key issues affecting their well-being, including school meals, inclusive policy processes, and support to school production units. Their contributions elevated child perspectives in policy dialogue and increased recognition of children as active stakeholders in national development.


Advocacy platforms expanded children's voice and visibility. Direct engagement through petitions, dialogue meetings, and national media created space for children to shape conversations that affect their lives.

These results show a shift toward more inclusive and responsive governance, where communities and children actively shape decisions, and public resources are directed toward improving essential services and child well-being.

Building on these results, World Vision Zambia will continue to scale integrated, locally led solutions that strengthen resilience and deliver sustainable impact for children and communities.

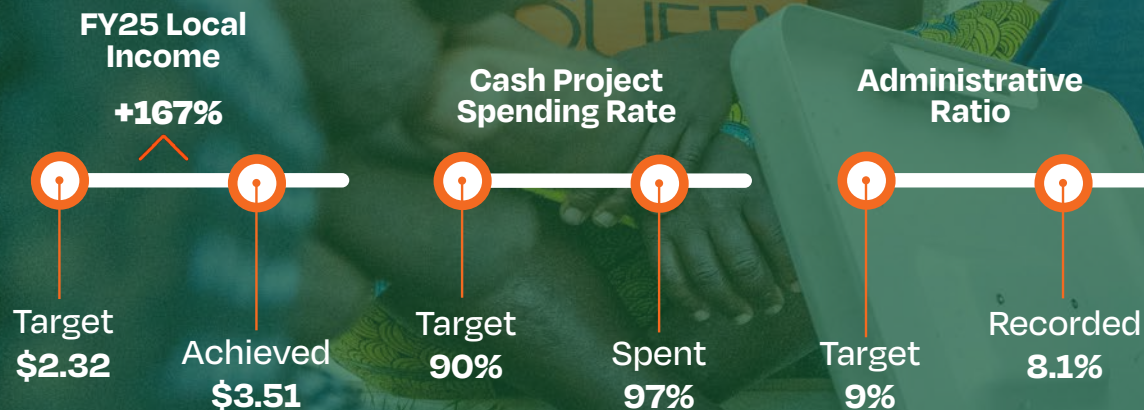


Building on these results, World Vision Zambia will continue to scale integrated, locally led solutions that strengthen resilience and deliver sustainable impact for children and communities.

Financial Summary

As of 30th September FY25, total cash funding commitments stood at US\$44.38 million, comprising US\$43.07 million in cash commitments and US\$1.31 million in gift notifications. This performance was 8.7% above the initial forecast of US\$39.60 million, reflecting strong delivery against targets. In addition, GIK (Gifts-in-Kind) commitments US\$9.34 million, which included US\$4.24 million of FY24 GIK in transit received during FY25, alongside US\$2.97 million in non-food GIK and US\$2.13 million in food GIK.

Local income commitments reached US\$3.51 million, significantly exceeding the initial goal of US\$1.32 million by 167%. The cash project spending rate stood at 97%, surpassing the annual minimum target of 90%, while the administrative ratio was recorded at 8.1%, remaining within the regional target of 9%.



This strong financial performance reflects World Vision Zambia's growing capacity to mobilize diversified funding and deliver at scale. The significant increase in local income demonstrates progress toward financial sustainability and stronger national partnerships.





Hope Grows with Water: 13-year-old Esther gains Agricultural Skills

In many rural parts of Zambia, schools struggle just to get enough water. This causes big problems like poor sanitation, hygiene issues, and limited chances for farming or other activities that could help students and their communities. That is how things used to be at Kasamba Secondary School in Zambia.

“Thanks to their (World Vision Zambia) support, we now have a borehole that gives us clean, reliable water. It’s made such a difference!” says 13-year-old Esther

Previously, it was impossible for the school to start any form of farming because it lacked water. But in 2022, World Vision drilled a borehole, giving Esther and her friends a chance to learn agriculture.

Reading Corners: Florence’s Power to Her Children’s Literacy

Illiteracy remains one of the biggest challenges facing rural Zambia, especially in communities like World Vision Zambia’s Luswepo Area Programme in Isoka district. Many children grow up without the necessary skills to read and write, limiting their opportunities for a better future. In these areas, lack of access to quality educational resources and awareness often leaves parents unaware of how they can support their children’s learning at home. This cycle of illiteracy hampers community development and perpetuates poverty.

“My vision is to have a big school someday, to help more children in the community” says 43 year old Florence Mugala
