2. Description of Project

Child Protection and Advocacy Project through Ending Violence Against Children (EVAC) project is committed to protecting children from abuse, neglect, exploitation and other forms of violence, and has chosen to utilize a systems approach to strengthen the protective environment around children. World Vision is embarking on a whole-of-World Vision campaign for the period 2017-2021 to end violence against children. All children need a strong child protection system — and this is particularly important to the most vulnerable children, since they are usually more at risk of abuse, exploitation or neglect.

The project's main goal is 'To empower communities with ability to better protect their children through EVAC efforts'.

To achieve this goal, the three outcomes were described.

• Outcome 1: The community, parents and caregivers provide caring and protective environment for children, especially the most vulnerable

- Outcome 2: Children have life skills to protect themselves and peers from exploitation, abuse and all forms of violence
- Outcome 3: The child protection mechanism is functioning effectively in protecting children from all forms of violence in all level

The project includes the set of specific interventions that focus on strengthening various elements of the CP system (both formal and informal elements) at the community level, thus empowering local communities to strengthen the protection of children from abuse, neglect, exploitation and other forms of violence. The project will strengthen both the protective environment for children, as well as children themselves, in order to improve their well-being and fulfill their rights to protection. The project provides comprehensive framework for CP work at the community level and will help to establish an evidence base for advocacy efforts at various levels. It uses a systems strengthening approach which emphasizes prevention, protection and response, coordination between sectors and integrated responses that can benefit all children.

4. Baseline Purpose and Objectives

A baseline assessment will be completed at the start of the project, with local stakeholders, to measure the status of all indicators and to understand the starting point of key elements of the work against which later progress will be measured. This will enable project indicators at output and goal/outcome level to be measured and tracked.

The objective of the baseline survey is described to assess the ability of parents and communities to better protect their children. The baseline report is to be used for monitoring benchmark of ITT and evaluating the project implementation.

Several objectives are determined to see the results into below mentioned areas;

- Parenting practice and attitude to care the children;
- Supportive relationships from community to most vulnerable children and their families;
- Girls' and boys' knowledge on prevention & protection from exploitation and abuse;
- Common forms of violence in their schools and communities;
- Vulnerable children and their families' opportunities to participate in decision making processes;
- Capacity of local partners to effectively coordinate the CP referral mechanism;

All objectives will be answered the baseline survey findings and reported to project team and Local responsible partners.

5. Methodology

World Vision Mongolia will select a local research consultant/institution to conduct the baseline survey. The selected research consultant will be required to prepare detailed research methodology in partnership with World Vision Mongolia.

Baseline survey will be proposed to apply both quantitative and qualitative data collection methods. A total of 10 khoroos of 2 districts of Ulaanbaatar city will be targets areas for this baseline survey.

5.1. Quantitative data collection methods

Base of this survey is the project logframe. Project team is intended to have baseline data at goal, outcome and if applicable, output levels. Possible key respondents or data sources are initially determined by project team; however the detailed data source and methods, and full questionnaires are required from consultant team. Project direct benefitted families are selected by project team before data collection and data collection will be covered through those selected 400 most vulnerable families. HH survey questionnaires are based on indicators of goal and outcomes which are shown in table 1. Consultant team should be submitted the draft questionnaires when they provide the technical proposal to WVIM for tender selection process.

5.2. Qualitative data collection methods

Key methods will be focus group discussions and key informant interviews with partners. Key partners include in the part of project audiences. Project team proposes the 10 FGDs with khoroo-based Child protection teams and 2 KIIs with district specialists. Moreover, consultant team is possible to suggest other partners to be interviewed based on information needs. All suggested tools will be discussed with WVIM to finalize.

5.3. Document Review

The baseline team will use all project documents. Once selected, the project team provide the documents. Also secondary data sources will be used for further data analysis.

5.4 Data analysis and interpretation

Primary data and data analysis process will be disaggregated by the sex and target khoroos. Collected data will be processed using the SPSS statistical data analysis software. Draft findings will be presented with project team and key partners to validate.
