CHILD MARRIAGE IN AFGHANISTAN

6 years is the legal age of marriage for girls in Afghanistan.

35% of Afghan girls are married by the age of 19 (UNICEF, 2017).

WOMEN EMPOWERMENT AND FAITH LEADERS

World Vision Afghanistan believes that faith leaders are key agents for bringing about transformational change in their community, therefore we actively engage them in our development activities to bring the community together, to mobilise the community for positive social change, to transfer sensitive messaging regarding gender based violence, early child marriage, the education of girls, and so on.



WHAT WORLD VISION HAS DONE SO FAR

SIGNED

an MoU with the Ministry of Religious Affairs providing government sanction and collaboration.

ESTABLISHED

24 community change groups with 450 women members.

IMPLEMENTED

a pilot project for innovative approaches to reduce child marriage. CONTEXTUALISED UNDP's Gender and Islam and three World Vision Social Action curriculums for the Afghan context.

TRAINED 4,158 Imams in 'Gender in Islam' and other World Vision curriculums since 2015.

LAUNCHED

our national It Takes A World to end violence against children campaign for rescuing the childhood of Afghan girls.



ACTIONS TAKEN BY FAITH LEADER PARTNERS

AWARENESS RAISING

With knowledge gained, during the Friday prayers Imams are raising awareness on gender equity, human rights, violence against women,

protection within families and community, early and/or forced marriage, and the rights of girls to education. Imams are also sharing these topics in small meetings in communities, schools, and institutions such as the military and police.

PRAYER FACILITY FOR WOMEN

A Lead Imam has gone as far as to build a facility for women next to the Mosque so women can come and listen to the Friday prayers and discussions.

AWARENESS CAMPAIGNS

Seven campaigns for communities about Child Marriage and Social Justice were conducted by World Vision trained Imams.
